- c. Eligible Bidders:
  - i. All bidders shall possess legal rights to supply the Goods under this Contract.
  - ii. A bidder shall not have a conflict of interest. All bidders found to have conflict of Interest shall be disqualified. Bidders may be considered to have a conflict of interest with one or more parties in this bidding process, if they:

- The manufacturer/s shall submit a certificate from their Government to iv. the effect that they have supplied minimum bulk quantity of 5,000 Nos. (3000 tons) EN 45E1/BS 90 (A) rails within the last ten (10) years and 50,000 tons of other rail profile within last three (03) years as per EN 13674 standard.
- a. Any person who acts as an agent or sub agent, representative or nominee for or on behalf of any bidder shall register himself before submission of bids with Registrar of Public Contracts Sri Lanka, as required by the Public Contracts Act No. 03 of 1987. The Original Certificate of Registration shall be submitted with the bid. The bids of those bidders who fail to submit such original certificate shall be rejected.
- b. The bidders shall also register themselves immediately after submission of the bids and prior to the award of the procurement, in terms of the Public Contracts Act No. 03 of 1987. The procurement shall not be awarded to any bidder unless such bidder had submitted the Certificate of Registration issued in terms of the Public Contracts Act to the relevant Procurement Committee.
